Description: - Professional capacity: The reference period which will be taken into account will be the last five years preceding the submission deadline. The candidate (each sole candidate or, in case of a consortium each member of the consortium) shall have professional licences, certificates, rights or equivalent for performance of the construction supervision services for sewerage networks and wastewater treatment plants in accordance with the laws of the country in which the candidate is established (a copy must be included in the application); b.
